

Victorian Coastal Awards 2018

Terms and Conditions / Privacy Statement

To be eligible for the Victorian Coastal Awards 2018, your entry must meet the following requirements:

1. The Awards are open to individuals, community groups, committees of management (CoMs), Traditional Owners, schools, not-for profit organisations, private companies, and local and state government departments and agencies that have demonstrated a commitment to sustainable coastal practices and improvement and care of Victorian coastal and/or marine environments.
2. Award submissions will only be accepted through the online nomination form on the VCC website: www.vcc.vic.gov.au. If you encounter any difficulties, please contact the VCC Secretariat staff via email to vcc@delwp.vic.gov.au, or by phoning 03 9637 8893
3. Images and supporting material that demonstrate the success of the nomination are highly encouraged. The submission, including attachments may not exceed 5MB and may include up to 5 images.
4. Nominations must be online via the Victorian Coastal Council website. The submission, including attachments may not exceed 5MB and may only include up to 5 images. If there is a requirement to provide large attachments or high resolution photographs, please supply these via email to vcc@delwp.vic.gov.au, or by USB drive posted to:

5. Entries must address each of the key selection criteria outlined on the nomination form for that category.
6. Projects must be current or have been completed in the last 2 years.
7. Nominations for a Victorian Coastal Award made in previous years may be resubmitted only if it did not win an Award, and only if the project is still current or has been completed in the last 2 years.
8. Projects, individuals and groups can be nominated in more than one category. However, a separate entry form must be filled out and submitted for each category.
9. The decision of the judging panel will be final and no correspondence will be entered into.
10. All material submitted to the Awards becomes the property of the Victorian Coastal Council. The Victorian Coastal Council reserves the right to use all entries received for publicity and educational purposes. No material submitted will be returned.
11. At the discretion of the judging panel, the Victorian Coastal Council may nominate recipients or finalists of Victorian Coastal Awards to the National Landcare Awards, or other environmental award programs.

12. The personal information provided by you to the Victorian Coastal Council will be used to assess nominations for the Victorian Coastal Awards 2018 and convey information about the Awards. Please note that the contact details and photographs of Award nominations may be provided to media for promotional purposes. 13. Nominations including all supporting material should be submitted via email and must be received by Friday **23 February 2018**. Late submissions will not be accepted.
